CERTIFICATION DESCRIPTIONS

CBLP – Chesapeake Bay Landscape Professionals are trained in practical conservation landscaping methods with the goal of protecting our streams and waterways while creating aesthetically pleasing habitats. All CBLPs have passed exams at their level and maintain their credentials with continuing education. Level 1 indicates training in the concepts and practices of Chesapeake Bay landscaping and Level 2 indicates advanced training and experience in the design and installation of practices covered in Level 1.

ASW – Arlington Stormwater Wise training
